## 4. Minutes

Mr. Nelson offered a motion to approve the minutes of the October 29, 2021 meeting, and was seconded by Mr. Kothe. The motion was unanimously approved.

# Items for Action, as recommended for approval by the Technical Committee

- 5. Approval of Amendment #12 to the FY 2022 2026 TIP, State Project No. D082-2, consisting of land acquisition pursuant to Route 9 improvements, cost reduced from \$200,000 to \$151,000; state funding only.
  - Ms. Kramp noted that the Technical Committee tabled consideration of Amendment 12, due to uncertainty about the extent of the project area as described. The amendment will be reconsidered in January.
- 6. Approval of Amendment #13 to the FY 2022 2026 TIP, State Project No. SP 2022-2, consisting of structure preservation (bridge deck sealing) at 19 non-interstate locations in the MPA; project number change to reflect carryover.
  - Mr. Stokes moved for approval of Amendment #13 and was seconded by Mr. Otto. The motion passed unanimously.
- 7. Approval of Amendment #15 to the FY 2022 2026 TIP, State Project No. BP 2022-1, consisting of railroad engineering associated with structure painting at four locations within the MPA, with added funding of \$74,000 for this element of the overall project.
  - Mr. Nelson moved for approval of Amendment #15 and was seconded by Mr. Otto. The motion passed unanimously.
- 8. Approval of Amendment #14 to the FY 2022 2026 TIP, State Project No. SP 2022-1, consisting of structure preservation through bridge deck sealing at 28 interstate locations within the MPA.
  - Mr. Otto moved for approval of Amendment #14 and was seconded by Mr. Nelson. The motion passed unanimously.

Mr. Lai noted that this is Ms. Kramp's final meeting of the Policy Committee, in that she is not seeking re-appointment to the Regional Planning Commission.
