#### Items for Action, as forwarded by the Technical Committee

##### Approval of FY 2019-2023 Transportation Improvement Program, Amendment #4

Amendment #4 revises costs for IDOT project J043, which consists of Phase I engineering regarding IL Route 9 and U.S. 150, from east of I-74 to Royal Pointe Drive, and from Locust Street to Towanda Ave, all in Bloomington. Mr. Nelson noted that the amendment reflects increased costs for the Phase I study of ADA improvements, resurfacing and reconstruction on Route 9 and U.S. 150.



Mr. Otto offered a motion to approve Amendment 4 to the FY 2019-2023 TIP, and was seconded by Judge Caisley. The motion was unanimously approved.

#### *FY 2020 – 2024 Transportation Improvement Program*

Ms. Sicks noted that the draft of the TIP update will be considered by the Technical and Policy committees in late May.
