1. Call to Order

Mr. Lai called the meeting to order at 10:34 a.m. Ms. Sicks accounted for Committee members and other present through electronic means, including through phone connection. Under Governor Pritzker's Executive Orders 2020-07, 2020-10 and 2020-18, and the March 9, 2020 Disaster Proclamation, a quorum was present.

2. Public Comment

Ms. Sicks advised that no request for public comment was received, nor were any comments submitted in advance of the meeting. She noted that staff are continuing to research a virtual meeting practice to permit public access to such meetings.

3. Minutes

Mr. Aldrich offered a motion to approve the minutes of the February 21, 2020 meeting of the Technical Committee, and was seconded by Mr. Kothe. The motion was unanimously approved.

Items for Action & Referral to the Policy Committee

4. <u>Approval of Amendment #6 to the FY 2020-2024 Transportation Improvement</u> Program

Ms. Sicks noted that the amendment consists of an additional project J043-L in fiscal year, related to project J043, for land acquisition with state-only funding. Mr. Nelson noted that the project consists of preliminary engineering on Route 9; the land acquisition element

Mr. Otto offered a motion approving Amendment #6 for referral to the Policy Committee, and was seconded by Mr. Magee. The motion was unanimously approved.

5. <u>Approval of Amendment #7 to the FY 2020-2024 Transportation Improvement Program</u>

Ms. Sicks noted that Amendment #7 consists of a funding revision to project D082-1, in FY 2021, installing standard overlay – 3P Policy/ADA improvements on Veterans Parkway from west of Commerce Parkway to 0.1 mile north of Washington Street. The total cost is now \$6,500,000, of which \$5,201,000 is NHPP funding, and \$1,299,00 is state matching funds.

Mr. Kothe offered a motion approving Amendment #7 for referral to the Policy Committee, and was seconded by Mr. Aldrich. The motion was unanimously approved.

<u>Items of Information or Discussion</u>

6. <u>TIP Development and Publication Schedule</u>

Ms. Sicks reviewed the schedule for submittal of projects for the FY 2021-2025 TIP, noting that she hopes to have the project lists from staff by April 24. The goal is to approve the draft for publication on May 15th. There will be a Policy meeting on May 22nd, if needed.
